Chamblee called the meeting to order at 2:00 p.m. in the Billie Nowlin Conference Room in Lloyd Ricks. Wolverton moved, seconded by Bridges to approve the minutes of the February 17, 2006 meeting. Nobles stated that she had attended the February meeting. The correction was noted. The motion passed unanimously.

Bridges moved, seconded by Wolverton, to approve the addition of ADS 4623/6623 Animal Biotechnology and Application of Molecular Biology. The motion passed unanimously.

Bridges moved, seconded by Henington, to approve the addition of AIS 8113 Planning, Organizing, and Managing AEST Programs. The motion passed unanimously.

Bridges moved, seconded by Palmer, to approve the modification of PSY 3713 Cognitive Psychology. The motion passed unanimously.

Bridges moved, seconded by Wolverton, to approve the modification of BIS 1733 Visual Basic Applications. A question was raised about the "Grade of B or better in BIS 1012" prerequisite. K. Rogers explained that BIS 1012 is an introductory class, and that it is necessary for students to do very well in BIS 1012 if they plan to be successful in the MIS program. The motion passed unanimously.

Bridges moved, seconded by Wolverton, to approve the modification of BIS 4533/6533 Management Support Systems. The motion passed unanimously.

Bridges moved, seconded by Wolverton, to approve the review of EC 8113 Labor Theory and Analysis, EC 8323 Economic Analysis of Developing Nations, and EC 8423 Public Finance. The motion passed unanimously.

Bridges moved, seconded by Palmer, to approve the modification of FIN 2003 Personal Money Management, INS 3403 Financial Planning, and INS 3413 Introduction to Personal Financial Planning. The motion passed unanimously.

Bridges moved, seconded by Wolverton, to approve the modification of INS 4503/6503 Enterprise Risk Management. The motion passed unanimously.

Bridges moved, seconded by Palmer, to approve the deletion of ABE 8913 Agricultural and Biological Engineering Seminar. The motion passed unanimously.

Bridges moved, seconded by Henington, to approve the modification of ASE 4433/6433 Fundamentals of Numerical Grid Generation. The motion passed unanimously.

Bridges moved, seconded by Ebanks, to approve the addition of CSE 4613/6613 Bio-computing, CSE 4623/6623 Computational Biology, and the addition of the Computational Biology Certificate program. Nobles asked for a clarification on the students that would pursue the certificate. Hudson explained that she had spoken with Susan Bridges about that issue. S Bridges indicated that students would be enrolled in one of the Master degree programs listed in the proposal. Students would not be enrolled just for the certificate. The motion passed unanimously.

Bridges moved, seconded by Bourgeois, to approve the modification of the Bachelor of Architecture. Bourgeois explained the modification was necessary to add a required college core course and that an architecture elective was being deleted. The motion passed unanimously.

Bridges moved, seconded by Henington, to approve the modification in the Master of Science in Information Systems. The motion passed unanimously.

Bridges moved, seconded by Palmer, to approve the modification of the Master of Science in Computer Science, and the Doctor of Philosophy in Computer Science. The motion passed unanimously.

Bridges moved, seconded by Wolverton, to approve the modification of Doctor of Philosophy in Electrical and Computer Engineering. The motion passed unanimously.

Chamblee reminded the committee that its April meeting would be held at Harvey's on Friday, April 21 at 12 noon. Hudson stated that the lunch menu had been set but changes could be made. She asked members to contact her if they wished to make a change.

Bridges moved, seconded by Henington, to adjourn at 3:15 p.m.
