Belli called the meeting to order at 2:00 p.m. in Lloyd-Ricks Annex, north end. An announcement was made that the November meeting would be changed to the 20th (from the 13th), but the proposal deadline would remain the same.

Chromiak moved, seconded by Henington, to approve the minutes of the April 24, 2003 meeting. The motion passed unanimously.

Bridges moved, seconded by Wolverton, to approve the addition of CVM 4523/6523 Basic Neuroscience, CVM 8453 Mechanisms of Toxic Action, CVM 8523 Organ Systems Toxicology I, CVM 8533 Organ Systems Toxicology II, and CVM 8801 Seminars in Veterinary Anesthesiology. The motion passed unanimously, contingent on receiving additional information from Nicolay Filipov concerning graduate requirements for CVM 4523/6523.

Chromiak moved, seconded by Lewis, to approve the modification of ABE 4163 Machinery Management for Agro-Ecosystems, and BCH 4414 Isotopes Tech I. The motion passed unanimously.

Bridges moved, seconded by Wolverton, to approve the modification of BCH 4805/6805 Biochemical Methods. Deeds motioned, seconded by Lewis, to table the proposal pending the submission of the cross-listed course GNS 4805/6805. The motion to table passed unanimously.

Chromiak moved, seconded by Henington, to approve the deletion of GNS 9000 Genetics Research/Dissertation. The motion passed unanimously.

Bridges moved, seconded by Chamblee, to approve the modification of CO 3813 Public Relations Case Problems. The motion passed unanimously.

Chamblee moved, seconded by Henington, to approve the addition of BIS 4113/6113 Business Information Systems Security Management. The motion passed unanimously, contingent on receiving clarification on the proposed instructor of record, and the total number of class hours to be apportioned by percentage in the topic outline.

Lewis moved, seconded by Wolverton, to modify the Guide and Format to accept the use of percentages as a valid method of presenting the allocation of class hours in topic outlines. The motion passed unanimously.

Henington moved, seconded by Lewis, to approve the addition of EPY 3513 Writing in the Behavioral Sciences, the modification of the B.S. program in Educational Psychology, and the addition of EPY 3513 to the core category of Junior/Senior Writing. After discussion, Wolverton moved, seconded by Chromiak, to table the three proposals pending clarification of the prerequisites, and the title of the course. The motion to table passed unanimously.

Bridges moved, seconded by Chamblee, to approve the modification/review of EPY 8273 Neuropsychology & Neuropsychological Assessment. The motion passed unanimously.

Rogers moved, seconded by Bridges, to approve the addition of CHE 2212 Chemical Engineering Analysis, the deletion of CHE 3823 Chemical Engineering Analysis & Simulation, the modification of CHE 4133/6133 Process Design, and the modification of the B.S. program in Chemical Engineering. The motion passed unanimously.

Lewis moved, seconded by Chamblee, to approve the deletion of CS 2314 Computer Science II and CS 5133 Introduction to Computer Systems, and the modifications of CS 3183 System Programming, CS 3813 Introduction to Formal Languages and Automata, CS 4153/6153 Data Communications and Computer Networks, CS 4413/6413 Principles of Computer Graphics, CS 4504/6504 Database Management Systems, CS 4733/6733 Operating Systems I, CS 4833/6833 Introduction to Analysis of Algorithms, and the modification of all courses with the prefix "CS" to a new prefix, "CSE". The motion passed unanimously.

Chamblee moved, seconded by Wolverton, to approve the addition of FO 8313 Spatial Statistics for Natural Resources. The motion passed with a vote of 14 in favor, with one abstention.

Chamblee moved, seconded by Wolverton, to approve the modification of the B.S. program in Agricultural Economics. The motion passed unanimously.

Deeds moved, seconded by Lewis, to approve the modification of the B.S. program in Agricultural Information Science. The motion passed unanimously.

Bridges moved, seconded by Wolverton, to approve the modification of the B.S. program in Agriculture Engineering Tech & Business, Land Surveying Option. After discussion, Henington

Bridges moved, seconded by Wolverton, to approve the modification of the M.S. and P.h.D programs in Entomology, and the deletion of the M.S. and P.h.D program in Plant Pathology, and the M.S. program in Agricultural Pest Management. The motion passed unanimously.

Deeds moved, seconded by Chromiak, to approve the modification of the M.S. program in Biochemistry and the P.h.D program in Molecular Biology. The motion passed unanimously.

Bridges moved, seconded by Wolverton, to approve the modification of the B.S. program in Education, Elementary Education, and the B.S. program in Education, Secondary Social Studies Education. The motion passed unanimously.

Lewis moved, seconded by Wolverton, to approve the use of ARC 2713 Passive Systems as a core course in the Natural Sciences category. The motion passed unanimously.

Deeds moved, seconded by Lewis, to remove the addition of EPP 4152/6152 Advanced Fungal Taxonomy-Fungi Imperfecti, EPP 4162/6162 Advanced Fungal Taxonomy Ascomycetes, EPP 4172/6172 Advanced Fungal Taxonomy-Flashy Basidiomycetes, and EPP 4182/6182 Advanced Fungal Taxonomy-Oomycetes and Zygomycetes from the table. The motion passed unanimously. The original motion to approve the proposals also passed unanimously.

Henington moved, seconded by Wolverton, to adjourn at 3:40 p.m.
