Discussion on this course followed and questions arose that could not be answered at the meeting. Wolverton moved, seconded by Lewis, to table the course. Belli is to invite a representative from the Department of Mathematics and Statistics to the next UCCC meeting to provide more information on the course. The motion to table MA 1453 passed unanimously.
